Please note: The minimum loan amount is £50,000, unless otherwise stated.

- 1 Early Repayment Charges apply during the product term. Up to 10% of the original mortgage amount can be overpaid each year without charge, however, if the mortgage is redeemed or switched to another product during the product term then the Early Repayment Charge will apply. #### Interest Cover Ratio (ICR)

The ICR formula to calculate the minimum rental income required is: loan amount x interest stress rate x taxpayer stress rate / 12 = the minimum monthly rental cover.

The ICR to calculate the maximum loan amount is: monthly rental income x 12 / interest stress rate / tax payer stress rate = maximum loan amount.

### Example ICR calculation:

#### Basic Rate Taxpayer on an example product

Loan amount required	£150,000
Reference rate	5.50%
Monthly payment at 5.50% reference rate (interest only)	£687.50
Monthly payment x 125% (minimum rental cover)	£859.38
